Deal Terms Defined



CASH ON CASH

A cash on cash return is the percentage of your initial investment that you will earn back annually.



IRR

We use this metric to predict how profitable an investment opportunity will be. IRR is a discount rate that makes the net present value (NPV) of all cash flows equal to zero in a discounted cash flow analysis. IRR calculations rely on the same formula as NPV does. It predicts the growth of the investment and how well it will perform over time.




CAPITALIZATION RATE

Capitalization rate is calculated by dividing a property's net operating income by the current market value. This ratio, expressed as a percentage, is an estimation for an investor's potential return on a real estate investment.

Target Returns

> CASH ON CASH 8% preferred return 9.5%-12% annual return 18%-26% > CAPITALIZATION RATE 6%-12%
